RESOLUTION 19-01-05-20

**A RESOLUTION TO CANCEL A RESIDENTIAL LAND LEASE
AUTHORIZED BY RESOLUTION 18-04-132-19 TO MILLE LACS BAND
HOUSING DEPARTMENT TRACT 410T001001**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 18-04-132-19 authorized a residential land lease for the purpose of obtaining a lease site located at 17055 Wabashkiki Drive, Onamia, MN 56359; and

WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410T001001 Located in the North half (N½) of the Northeast Quarter (NE¼) of Section Twenty (20), Township Forty-three North (43N), Range Twenty-seven West (27W) Mille Lacs County, Fourth Principle Meridian, more particularly described as follows:

Lot Forty-three (43), Bugg Hill Plat; and

WHEREAS, the home was demolished in April 2019, and Mille Lacs Band Housing Department has no plans to rebuild, the lessee voluntarily relinquishes the land lease authorized by tribal Resolution 18-04-132-19 and requests this lease site revert back to the Band.


