RESOLUTION 19-01-86-20

A RESOLUTION AUTHORIZING A LAND LEASE FOR RESIDENTIAL PURPOSES TO THE MILLE LACS BAND HOUSING DEPARTMENT TRACT 410TF000316

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, the Mille Lacs Band Housing Department respectfully requests a land lease for residential purposes; and
- WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows

Part of Tract #410TF000316, described as the Northeast Quarter (NE¼) of the Southeast Quarter of the Southwest Quarter (SE ¼ SW¼) of Section Two (2), Township Forty-two North (42N), Range Twenty-seven West (27W), Mille Lacs County, Minnesota, Fourth Principle Meridian

Lot Six (6), Block One (1) of Driftwood Beach Plat.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby authorizes a land lease for the property described herein for residential purposes be issued to the Mille Lacs Band Housing Department for a period of 25 years, renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and



BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Band; and

BE IT FURTHER AND FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 13th day of February, 2020 at Chi Minising, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

The Division of Land Management submits this Resolution to grant, on behalf of the Mille Lacs Band Housing Department, a land lease located at 14789 Twilight Road, Onamia, MN 56359.

- 08/26/2015: Band acquires property;
- 05/09/2016: The Real Estate Department turns structure over to CMD pursuant to 12 MLBSA § 13(c). “Any land acquisition performed by the Mille Lacs Band of Ojibwe Indians Department of Natural Resources (“DNR”) that includes a house shall be leased to the Housing Department according to the following limitations:
 - Restricted to residential use; and
 - Following the area zoning requirements for a residential dwelling.”;
- 12/02/2019: Housing Department submits an Application for Lease and Director of Division of Land Management approves;
- 01/27/2020: Director of the Division of Land Management meets with Chief Legislative Counsel;
- 02/03/2020: Resolution submitted for Band Assembly Approval.

This home is part of the Twilight Road lake homes that are being turned over to MLBHD.
