RESOLUTION 18-04-36-20

A RESOLUTION TO TERMINATE A RESIDENTIAL LAND USE AGREEMENT AUTHORIZED BY RESOLUTION 12-03-39-07 FOR MILLE LACS BAND MEMBER [REDACTED] TRACT 410T001002

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 12-03-39-07 authorized a residential land lease to Band Member [REDACTED] for the purpose of obtaining a lease site; and

WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410 T 1002 located in the North One Half of the Northeast Quarter (N ½ NE ¼) of Section Twenty-eight, Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principle Meridian, Mille Lacs County, Minnesota.

More particularly described as Follows: Block One (1), Lot Eighteen (18), Vineland Hills Plat dated March 9, 1982 by Anthony E. Kerrick registered surveyor #12266; and

WHEREAS, the trailer was demolished, lessee no longer resides at this lease site, the property is considered abandoned and will remain as greenspace.
