RESOLUTION 18-04-24-20

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2020 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY HVAC UPGRADES

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and


WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on November 4, 2019 to open a 2020 capital project for HVAC Upgrades at Grand Casino Hinckley in the amount of: Four hundred ninety-five thousand dollars and no cents (\$495,000.00).

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2020 Capital Budget.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 12th day of November, 2019 at Chi Minising, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

Please accept this letter as a formal request to open a FY2020 capital project related to HVAC Upgrades at Grand Casino Hinckley. **The capital budget for this project is \$495,000.**

This project includes replacement of multiple units that are old and near end of life, the replacement schedule includes:

Upgrade exhaust in Double Diamond Smoking Area	\$20,000
Upgrade heat pumps in hotel rooms	\$100,000
Add entrance heat to entry by Grille House	\$30,000
Resize and relocate hotel lobby heat pumps	\$20,000
Upgrade seal on chiller #5	\$25,000
Upgrade heating and AC in slot warehouse	\$35,000
Control Upgrades	\$120,000
Seal pan in cooling tower #4	\$20,000
Upgrade roof units on warehouse	\$60,000
Replace heat pumps in hotel retail	\$10,000
Upgrade exhaust fans	\$43,000
Miscellaneous unforeseen repairs	<u>\$12,000</u>
	\$495,000
