

## **JOINT RESOLUTION 19-01-76-20**

## A JOINT RESOLUTION IN SUPPORT OF THE APPOINTMENT OF LINDSAY MISQUADACE-BERG TO THE AMERICAN INDIAN ADVISORY COUNCIL

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive recognize the need to have representation on the American Indian Advisory Council; and
- WHEREAS, the Band Assembly and Chief Executive do hereby name Lindsay Misquadace-Berg, Director of Four Winds Lodge Treatment Program for the Band, to attend and participate in all American Indian Advisory Council meetings on behalf of the Band; and
- WHEREAS, all materials or information obtained at the meetings shall be completely and factually distributed to Elected Officials and department heads as it pertains to Mental Health, Chemical Dependency, and Social Services programs within the Band and to comply with all necessary reporting requirements.
- NOW, THEREFORE, BE IT RESOLVED that the Band Assembly and Chief Executive hereby appoints Lindsay Misquadace-Berg to represent the Mille Lacs Band of Ojibwe on the American Indian Advisory Council.
- WE DO HEREBY CERTIFY that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council, a quorum of legislators being present held on the 6<sup>th</sup> day of February, 2020 at Nayahshing, Minnesota by a vote of <a href="#scale="#scale=">SFOR</a>, <a href="#scale="#sca
