RESOLUTION 18-04-27-20

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2020 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY SLOT CAPITAL

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on November 4, 2019 to open a 2020 capital project for Slot Capital at Grand Casino Hinckley in the amount of: Three million, one hundred sixty-two thousand, five hundred dollars and no cents (\$3,162,500.00).

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2020 Capital Budget.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 12th day of November, 2019 at Chi Minising, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

Please accept this letter as a formal request to open a FY2020 capital project related to slot product at Grand Casino Hinckley for the fiscal year. The capital budget for this project is **\$3,162,500**.

Hinckley is purchasing proven platforms that are currently performing well above house average from manufacturers that have demonstrated depth in content development and a solid roadmap for content development in the coming years. This project is to purchase 115 slot machines which is approximately 5% of the entire floor. The cost is approximately \$27,500 per unit, which includes the cabinet, locks, IGT Advantage, bases and licensing fees.
