**JOINT RESOLUTION 19-01-79-20**

**A JOINT RESOLUTION DESIGNATING THE MILLE LACS BAND COURT OF CENTRAL JURISDICTION, COURT OF APPEALS, WITH ORIGINAL JURISDICTION TO DECIDE ELECTION CONTEST DISPUTES DURING THE 2020 MINNESOTA CHIPPEWA TRIBE ELECTION ON THE MILLE LACS RESERVATION**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 2, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band is one (1) of the six (6) Chippewa Bands forming the Minnesota Chippewa Tribe (“MCT”); and
- WHEREAS, Article III of the Minnesota Chippewa Tribe Revised Constitution and Bylaws empower the Tribal Executive Committee (“TEC”) as the governing body of the MCT; and
- WHEREAS, the Secretary-Treasurer and the Chief Executive are voting members of the TEC; and
- WHEREAS, the MCT Election Ordinance (Revised 12/09/19), Chapter III, Section 3.4 sets forth the jurisdictional limitations of the MCT Tribal Election Court of Appeals, and specifically mandates that the “Band governing body will notify the Tribe of a decision to use the Court before the date of a scheduled primary election;” (Chapter III, Section 3.4 (B)(2)); and
- WHEREAS, the Band Assembly and Chief Executive have determined that it is in the Band’s best interest to follow 5 MLBSA § 111(f) authorizing original jurisdiction over election disputes in the Mille Lacs Band of Ojibwe’s Court of Central Jurisdiction Court of Appeals.


