**JOINT RESOLUTION 18-04-124-19**

**A JOINT RESOLUTION DENYING THE ENROLLMENTS INTO THE MILLE LACS BAND, MILLE LACS RESERVATION FOR THOSE WHO DO NOT MEET THE 1/4 DEGREE REQUIREMENT OF THE MINNESOTA CHIPPEWA TRIBE**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2(d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the Band; and
- WHEREAS, pursuant to 4 MLBSA § 6, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly and Chief Executive have reviewed the following applications for enrollment:

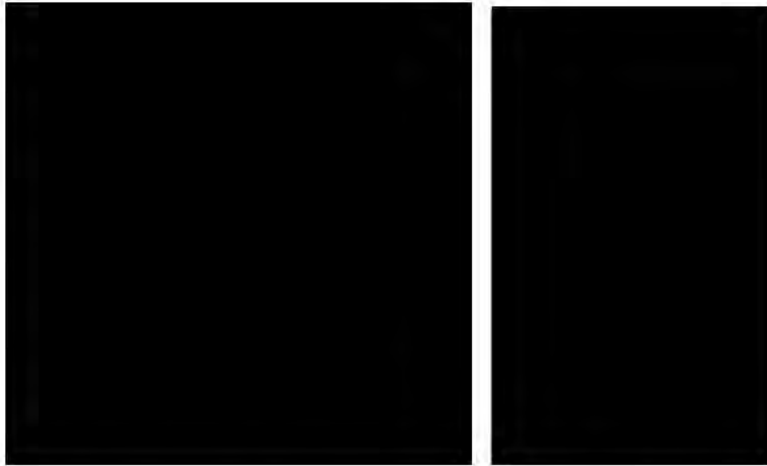


NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly and Chief Executive deny the above applications for enrollment, they do not meet the requirements found in Article II of the Minnesota Chippewa Tribal Constitution.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17<sup>th</sup> day of October, 2019 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
