**RESOLUTION 18-04-35-20**

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION 16-01-122-14 AND MODIFIED BY RESOLUTION 16-02-13-15 FOR MILLE LACS BAND MEMBER [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected governing body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 16-01-122-14 authorized a residential land lease to Band Member 410B037882 for the purpose of obtaining a lease site for residential purposes; and

WHEREAS, Resolution 16-02-13-15 modified the legal description for the correct Lot; and

WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410T000116, located in the West one half of the Southeast one Quarter of the Southwest one Quarter of the Southeast one Quarter (W½ SE¼ SW¼ SE¼) of Section Seventeen (17), Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principle Meridian, Mille Lacs County, Minnesota.

More particularly described as follows: Lot Nine (9), Bugg Hill Trailer Park Plat.
