RESOLUTION 19-01-103-20

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2020 ECONOMIC DEVELOPMENT FUNDS FOR WEWINABI CAPITAL PROJECTS AND 1ST AND 2ND QUARTER LOSSES

WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(b) to appropriate all Band revenue regardless of source; and

WHEREAS, the Band Assembly is also authorized under 3 MLBSA sec. 2(d) to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested an additional appropriation on March 12, 2020 to fund capital projects that were approved in FY2020 for:

WHEREAS, Joseph S. Subject: Wewinabi Operating Losses - REVISED

Dear Distinguished Members:

We are requesting appropriation in the amount of \$774,090 from the Economic Development fund to cover 1^{st} and 2^{nd} quarter losses at the Wewinabi businesses.

As travel restrictions and social distancing efforts have become more widespread due to the COVID-19 crisis, our hotels are experiencing significant drops in demand with an uncertain duration, which puts the company in a situation of not having the available hotel cash flow to pay for the operations of the in-district businesses, as it typically would. The in-district businesses are community-focused, providing needed services and local jobs to the community. Throughout this crisis, they are managing their businesses as effectively as possible, but they are in need of this support.

Subject: Wewinabi Capital Projects

Dear Distinguished Members:

We are requesting an appropriation for capital projects in the amount of \$64,158 for Grindstone Laundry. These projects include:

EMX Conveyer to be utilized with the current EMX feeder. This ergonomically correct conveyer will allow three stations to be open at one time and provide for a faster processing time. The project also increases safety for Associates when moving the washed sheets from the carts to the dryers. **Budget for this project is \$27,725.**

Brushes to be utilized with the existing Double Barrell ironing line. The brushes pull the sheets tight as they are entering the ironer to ensure the edges are flat, which dramatically increases the quality of the finished product. This purchase resolves an outstanding quality control issue. Budget for this project is \$36,433.

Subject: Wewinabi Capital - Super Stop Septic System Repair

Dear Distinguished Members:

We are requesting an additional appropriation for the Super Stop Septic System Repair capital project in the amount of \$35,031. When the project went through permitting Mille Lacs County required the installation of a MBBR (Moving Bed Biofield Reactor) Pretreatment System as the drain field is close to drinking water wells and it does not meet setback requirements without the MBBR. Below is a breakdown of the bid comparisons:
