RESOLUTION 19-03-62-21

A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED **BY RESOLUTION 10-03-30-03**

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federallyrecognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBS § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 10-03-30-03 authorized a residential land lease for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

A part of Tract # 410T001002, located in the North one-half (N½) of the Northeast one-quarter (NE¼) of Section Twenty-eight (28), Township Forty-three North (T43N), Range Twenty-seven North (R27N), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Three (3), Block One (1), Vineland Hills Plat dated March 9, 1982 by Anthony E. Kerrick registered surveyor # 12266; and

WHEREAS, the lessee voluntarily relinquishes the land lease authorized by tribal resolution 10-03-30-03 requests this lease site revert back to the Band.

NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the cancellation of Resolution 10-03-30-03; and

BE IT FURTHER AND FINALLY RESOLVED that the lease site will revert back to the Band.
