## **RESOLUTION 19-04-75-21**

## A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2021 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBS § 3(b) to appropriate all Band revenue regardless of source; and
- WHEREAS, the Band Assembly is also authorized under 3 MLBS § 3(d) to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on July 7, 2021 to open 2021 capital projects for:

  Slot Machine Capital H20-EMR-01/H20-EXC-01 at Grand Casino Hinckley in the amount of: Two hundred seventy thousand dollars and no cents (\$270,000.00); and

HVAC Tower 4 Replacement H20-EMR-01/H20-EXC-01 at Grand Casino Hinckley in the amount of: Two hundred ninety-one thousand one hundred forty-five dollars and no cents (\$291,145.00).

- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2021 Capital Budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 14<sup>th</sup> day of July, 2021 at Nayahshing, Minnesota by a vote of 3 FOR, AGAINST, SILENT.
