RESOLUTION 19-02-13-21

A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION 17-02-138-16 TO MILLE LACS BAND HOUSING DEPARTMENT TRACT 410T000222

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution 17-02-138-16 authorized a residential land lease for the purpose of obtaining a lease site; and
- WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:
Tract No. 410T000222, described as Government Lot 7 of Section Eighteen (18), Township Forty-one North (41N), Range Seventeen (17) of the Fourth Principle Meridian, Pine County, Minnesota. Further described as; Lot Twenty (20) of the survey and plat “Owl Wise” by Loucks Associates. Containing 1.02 acres more or less; and
- WHEREAS, the lessee voluntarily relinquishes the land lease authorized by tribal Resolution 17-02-138-16, MLBHD has no plans to rebuild and requests this lease site revert back to the Band.
- NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the cancellation of Resolution 17-02-138-16; and
