**RESOLUTION 19-03-69-21**

**A RESOLUTION TO TERMINATE A RESIDENTIAL LEASE  
AUTHORIZED BY RESOLUTION 05-03-75-93 FOR MILLE LACS BAND  
MEMBERS [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBS § 3 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 05-03-75-93 authorized a residential land lease to Mille Lacs Band Member [REDACTED] and Mille Lacs Band Member [REDACTED] for the purpose of obtaining a lease site; and

WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract #410T000014, in Section 28, Twp 43N, Range 27W, Kathio Twp, Mille Lacs County, State of Mn. Described thus: Beginning at the NE corner of Lot A-14, thence West 124.44 feet along West side road, thence South 200 feet, thence East 121.44 feet, thence North 200 feet, thence East 121.44 feet, continuing along West side road 121.44 to the point of beginning.

WHEREAS, the lease is being terminated because Mille Lacs Band Member [REDACTED] passed away on April 3, 2001, and Mille Lacs Band Member [REDACTED] passed away on August 11, 2006; the home has been vacant for more than 30 days; the lease expired on February 4, 2018; and the lease site has been cleared as of May 24, 2021;

NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby authorizes termination of the lease approved by Resolution 05-03-75-93; and

BE IT FURTHER AND FINALLY RESOLVED that the lease site shall revert to the Band.
