## **RESOLUTION 19-04-73-21**

## A RESOLUTION TERMINATING THE STATE OF EMERGENCY

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected legislative body of the Mille Lacs Band of Ojibwe ("Band") a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBS § 3(a), the Band Assembly is empowered to "enact laws which promote the general welfare of the people[:]" and
- WHEREAS, according to 3 MLBS § 3(d), the Band Assembly is empowered to adopt resolutions; and
- WHEREAS, pursuant to 27 MLBS § 4, "[i]n the event of an emergency or disaster, the Chief Executive is authorized to declare a state of emergency through the issuance of an executive order[;]" and
- WHEREAS, on March 15, 2020, the Chief Executive signed Executive Order 2020-03, declaring the Non-Removable Mille Lacs Bands of Chippewa Indians to be in a state of emergency in response to the COVID-19 Pandemic; and
- WHEREAS. the state of emergency was intended "to provide the Band resources and services necessary to avoid the spread of COVID-19 in our community and to procure any necessary supplies and equipment[;]" and
- on May 14, 2021, the Commissioner of Health and Human Services issued WHEREAS, Commissioner's Order 21-05, ending the requirement for individuals to wear a mask or cloth face covering in government facilities and band-owned businesses; and
- WHEREAS, the Band procured doses of the COVID-19 vaccine, giving community members the opportunity to receive the vaccine to avoid the spread of COVID-19; and
- WHEREAS, since the beginning of the year, the number of confirmed COVID-19 cases throughout Minnesota has continued to decrease and new daily cases within the state of Minnesota have recently been trending at less than one hundred per day.
