RESOLUTION 19-03-56-21

**RESOLUTION AGREEING TO COMPLY WITH GUIDELINES
 ADOPTED BY THE MINNESOTA DEPARTMENT OF
 TRANSPORTATION FOR COMMUNITY WAYFINDING SIGNING**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, according to 3 MLBS § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band.

NOW, THEREFORE, BE IT RESOLVED that the Band hereby agrees to comply with the guidelines adopted by the Minnesota Department of Transportation (“MnDOT”) for Community Wayfinding Signing to be located within the rights of way of state (trunk) highways and local streets and roads within the Band’s 1855 Reservation boundaries; and

BE IT FURTHER RESOLVED that the Band agrees that it is solely responsible for the construction, installation, and maintenance of all sign structures and sign panels located within the 1855 Reservation boundaries at its own expense and that, if the community wayfinding signs are not properly maintained, the Band will remove the signs, at its sole expense, upon written request by MnDOT; and

BE IT FURTHER AND FINALLY RESOLVED that the Band agrees that, if the signs are not removed within thirty (30) days of after receipt of written notification by MnDOT, MnDOT will remove the signs at the sole cost and expense of the Band.

WE DO HEREBY CERTIFY that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 28th day of April, 2021, at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
