**RESOLUTION 19-03-64-21**

**A RESOLUTION TO TERMINATE A RESIDENTIAL LEASE  
AUTHORIZED BY RESOLUTION 11-02-22-05**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBS § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 11-02-22-05 authorized a land lease for residential purposes to Mille Lacs Band Member [REDACTED] for the purpose of obtaining a lease site; and

WHEREAS, the land lease was to be for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410T001001, located in the North one-half (N ½) of the Northeast one-quarter (NE ¼) of Section Twenty (20), Township Forty-three North (T43N) Range Twenty-seven West (R27W) Mille Lacs County, Fourth Principle Meridian, more particularly described as follows:

Lot Forty (40), Bugg Hill Plat.

The lease site is approximately 1 acre, more or less.

WHEREAS, the lease is being terminated because Lessee died on October 22, 2009 and the lease should be terminated so that it can be transferred back to the Band.

NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby approves the termination of the residential land lease previously authorized by Resolution 11-02-22-05; and,

BE IT FURTHER AND FINALLY RESOLVED that the lease site will revert back to the Band.
