## **RESOLUTION 19-03-72-21**

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2021 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY IGT ADVANTAGE UGA SERVICE WINDOW AND BUILDING ENVELOPE/CASINO UPDATE

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBS § 3(b) to appropriate all Band revenue regardless of source; and
- WHEREAS, the Band Assembly is also authorized under 3 MLBS § 3(d) to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on June 25, 2021 to open a 2021 capital project for:

  IGT Advantage UGA Service Window H21-SLT-02 at Grand Casino Hinckley in the amount of: Seven hundred thirty thousand dollars and no cents (\$730,000.00); and

  Building Envelope/Casino Update H21-PRO-03 at Grand Casino Hinckley in the amount of: Six hundred fifty-five thousand dollars and no cents (\$655,000.00).
- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2021 Capital Budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 30<sup>th</sup> day of June, 2021 at Nayahshing, Minnesota by a vote of 3 FOR, D AGAINST, D SILENT.
