RESOLUTION 19-02-34-21

**A RESOLUTION TO AMEND LAND LEASE DESCRIPTION FOR
RESOLUTION 19-02-142-20 TO THE MILLE LACS BAND HOUSING
DEPARTMENT**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected legislative body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBSA § 2 (d), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, tribal land leases are required on all tribal lands of the Band for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 06-01-93-94 authorized land leases to the Mille Lacs Band Housing Department for the purpose of establishing homesites; and

WHEREAS, the leases were for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective May 23rd, 1994, for the properties described in Resolution 06-01-93-94; and

WHEREAS, on August 26, 2020, the Band Assembly approved Resolution 19-02-142-20, which contained an incorrect legal description, for one of the properties described in Resolution 06-01-93-94; and

WHEREAS, said lease description is described in Resolution 19-02-142-20 as follows:

Part of Tract 410T001051, Government Lot Four (4) and the Southwest Quarter of the Southwest Quarter (SW¼ SW¼) of Section Twenty-one (21), Township Forty-three North (43N), Range Twenty-seven West (23W), Fourth Principle Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Twelve (12), Block Two (2) of North Connection Plat, containing one acre, more or less.

Part of Tract 410T001051, Government Lot Four (4) and the Southwest Quarter of the Southwest Quarter (SW¼ SW¼) of Section Twenty-one (21), Township

Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principle Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Twelve (12), Block Two (2) of North Connection Plat, containing one acre, more or less.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 28th day of December, 2020 at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
