**RESOLUTION 20-01-13-22**

**A RESOLUTION APPROVING THE CONTINUANCE OF THE MILLE LACS BAND GOVERNMENT, CIRCLE OF HEALTH, GAMING REGULATORY AUTHORITY, DEPARTMENT OF ATHLETIC REGULATION, SUPPLEMENTAL INCOME PROGRAM FOR ELDERLY, TRIBAL EMPLOYMENT RIGHTS OFFICE, HOUSING INITIATIVE, AND BAND MEMBER LEGAL SERVICES FISCAL OPERATIONS UNTIL APRIL 30, 2022**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBS §§ 3(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source and adopt resolutions; and

WHEREAS, 3 MLBS § 19 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and

WHEREAS, Band Assembly Bill 19-01-22-20, to fund the operations of the Band Government, Circle of Health, Gaming Regulatory Authority, Department of Athletic Regulation, Supplemental Income Program for Elders, and Tribal Employment Rights Office for Fiscal Years 2020 and 2021, expired September 30, 2021; and

WHEREAS, Band Appropriation Bill 19-02-12-21, to fund the operations of the Housing Initiative for Fiscal Year 2021, expired September 30, 2021; and

WHEREAS, the Band Assembly agrees to adopt a fifth (5<sup>th</sup>) continuing resolution until April 30, 2022.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of Band Government, Circle of Health, Gaming Regulatory Authority, Department of Athletic Regulation, Supplemental Income Program for Elders, and Tribal Employment Rights Office, Housing Initiative, and Band Member Legal Services fiscal operations until April 30, 2022.


