**SECRETARIAL ORDER 93-21**

**A SECRETARIAL ORDER AUTHORIZING THE DEPUTY REGISTRAR OF MOTOR VEHICLES TO RECYCLE DAMAGED LICENSE PLATES**

WHEREAS, pursuant to 3 MLBS § 7(a), the Secretary-Treasurer shall superintend and manage all fiscal operations, planning, and budgeting of the Non-Removable Mille Lacs Band of Ojibwe (“Band”) as authorized by the Band Assembly; and

WHEREAS, pursuant to 3 MLBS § 7(g), the Secretary-Treasurer may issue Secretarial Orders to implement decisions concerning matters of the fiscal affairs of the Band consistent with the powers under § 7, provided that such Secretarial Orders shall be in uniform format, issued consecutively, and have expiration dates; and

WHEREAS, the Band’s Department of Motor Vehicles is governed by Title 19 of Mille Lacs Band Statutes; and

WHEREAS, pursuant to 19 MLBS § 7, the Secretary-Treasurer “may prescribe all rules and regulations consistent with the provisions of [Title 19] through the issuance of Secretarial Orders[;]” and

WHEREAS, the Deputy Registrar of Motor Vehicles is in receipt of a great number of damaged Band license plates and has requested permission to recycle such plates at a local scrap metal business, receiving a marginal remuneration in return;

NOW, THEREFORE, BE IT ORDERED, that the Deputy Registrar of Motor Vehicles is authorized to recycle any damaged Band license plates that have been returned to the Department of Motor Vehicles, provided that any remuneration received be deposited into the Motor Vehicles Revenue Account.
