Workshop

October 24, 2022

Legal staff facilitated a workshop for the elected officials and staff regarding proposed revisions to Section 4 (Executive Officers) of Title 4 (Executive Branch). The elected officials and legal staff also reviewed proposed revisions to the Net Gaming Revenue Allocation Plan (RAP) and a resolution regarding housing policies.

The Joint Session of the Band Assembly amended and approved, with a waiver of the formal reading, Joint Session of the Band Assembly Resolution 20-02-27-22 (A Resolution Denying the Enrollments into the Non-Removable Mille Lacs Band of Ojibwe for Applicants Who Were Not Born to an Enrolled Mille Lacs Band Member).

October 25, 2022


