Work Scope:

Provide weekly maintenance services for District I parks through September 30, 2025.

Contractor will be responsible for labor and equipment to maintain the following Parks in District I: Bedausky, Ataage, Bugg Hill, Bugg Hill II, Oookwemin Loop and Nay Ah Shing and Lakeside. Weekly maintenance will include cleaning parks of debris/leaves, mowing and weed whipping. Contractor will also be responsible for picking up trash and informing Public Works of vandalism. Public Works will empty trash cans once a week or more if needed. **Some weekly service may be cancelled if grass doesn't grow via weather conditions.**

For payment, weekly invoices should be submitted for 100% of work completed which will be verified and inspected by Public Works Department.

Bidding Notes:

Your proposals shall include the following:

1. Bid should show weekly cost to do the above mentioned work schedule. Bid **must be signed** by contractor to be valid.
2. Copy of current MLB Vendor's License. (or a copy of submitted application)
3. Copy of current certificate of insurance for General Liability and Property Damage.
4. Copy of an authorized signature sheet if one is not already on file with the Mille Lacs Band.
