The scope of the work is to repair a settlement in Biitawaanakwad Dr. on the Mille Lacs Reservation. Work includes mobilization, replacing 100 lf. of curb and gutter, saw cutting bituminous pavement, subgrade preparation, mill bit joints, tac, patching bituminous pavement along new curb and overlaying the road to correct profile.
